The station creates a fire and explosion hazard completely beyond the capacity of distant volunteer firefighters, has few staff on site, and would be built on a former slave plantation atop the probably unmarked slave graves of Union Hill ancestors. Stand with Union Hill: Concert of Prayer

The Stand with Union Hill Concert of Prayer on December 18, 2018 was an interfaith prayer vigil to lift protection against the proposed Atlantic Coast Pipeline Buckingham Compressor Station in Union Hill, Virginia, on the eve of an important meeting by the Department of Environmental Quality's Air Pollution Control Board. The next day, the Air Pollution Control Board and the Virginia DEQ manage to dodge valid legal challenges to their procedure, public outrage over Governor Northam's recent stacking of board members in Dominion Energy's favor, and the presence of over 150 concerned citizens by not voting, and by declaring a new public comment period for the proposed ACP compressor station at Union Hill.
